1. ***The Money Market Gold Account*** is a special share deposit account and is issued in accordance with CentralAlliance Credit Union by-laws, Rules of the Commissioner of Credit Unions and Statutes of the State of Wisconsin.
2. ***Dividends*** to the Money Market Gold Account are determined by the Board of Directors of CentralAlliance. Dividends will be declared and posted monthly.
3. Member funds will be federally insured by the National Credit Union Share Insurance Fund to the maximum limit provided for in law.
4. The account is for the personal use of the depositor(s) only and is non-transferable.
5. ***Periodic Statements*** of the Account will be made available to members quarterly. Any objection respecting any item shown on the statement is waived unless presented in writing to CentralAlliance Credit Union within 60 days from the date the statement is mailed.
6. The Credit Union reserves the right to refuse an Account, or, at its discretion to terminate the deposit relationship at any time and without notice.
7. Only methods approved by CentralAlliance Credit Union may be used to withdraw funds from this account. The ***minimum withdrawal amount*** is five hundred dollars (***\$500.00***). Any number of withdrawals are permitted, however, only three (3) withdrawals by phone/or transfer are allowed per month.

This agreement governing the use of the Money Market Gold may be amended at any time. Such amendments will become effective immediately. Members will receive proper notification of any amendments or changes to this agreement. This account is also subject to such Other Items, Conditions, and Service Charges as the Credit Union may establish from time to time.
